Restriction of the use of certain hazardous substances in electrical and electronic equipment.

The Stat-X Group declares that all our products are in conformity with the requirements of the mentioned European directives.

Directive 2006/122/EC

Prohibition of Perfluoro octane Sulfonates (PFOS).

The Stat-X Group declares that all our products are in conformity with the requirements of the mentioned European directives.

Directive 2005/69/EC

Restriction on the marketing and use of Polycyclic aromatic hydrocarbons (PAHs).

The Stat-X Group declares that all our products are in conformity with the requirements of the mentioned European directives.

REACH Regulation (EC) 1907/2006, SVHC list as of June 27, 2024

Registration, Evaluation, Authorization and Restriction of Chemicals.

Stat-X Group products do not contain Substances of Very High Concern or if there are SVHC in the product, the content is less than the 0.1% (wt/wt) as defined by REACH Article 57, Annex XIV, Directive 67/548/EEC. Regarding the substance restrictions listed in Annexes XIV and XVII of the REACH regulations, the products of the Stat-X group also comply with the currently applicable regulations concentration limits and restrictions on use.

POPs - Regulation (EU) 2019/1021 on persistent organic pollutants

The aim of this regulation is to protect human health and the environment by eliminating or restricting the production and use of persistent organic pollutants (POPs) as defined in the Stockholm Convention on Persistent Organic Pollutants or the Protocol to the 1979 Convention on Long-Range Transboundary Air Pollution on Persistent Organic Pollutants. It seeks to minimise, or eliminate where possible, releases of such substances, and regulate waste containing or contaminated by them.

This is to declare that the products supplied by the Stat-X Group do not contain persistent organic materials as defined by the POP Regulation (EU) 2019/1021. The statements provided here are based on the information provided by our raw material suppliers and subcontractors, and business partners.

Toxic Substance Control Act (TSCA)

The United States Environmental Protection Agency (EPA), which is considered the counterpart of the European Chemicals Agency (ECHA), established the final rules of the Toxic Substances Control Act (TSCA) Section 6 (h) on 6 January 2021. With these, regulations were issued to reduce exposure to the PBT chemicals listed below, which became legally effective in March 2021.

Decabromodiphenyl ether (DecaBDE) CAS No. 1163-19-5

Phenol, isopropylated phosphate (3:1) or (PIP (3:1)) CAS No. 68937-41-7

2,4,6-Tris(tert-butyl)phenol (2,4,6-TTBP) CAS No. 732-26-3

Hexachlorobutadiene (HCBD) CAS No. 87-68-3

Pentachlorothiophenol (PCTP) CAS No. 133-49-3

The Stat-X Group is committed to environmental and health safety. Based on our knowledge and that of our suppliers, our products do not contain substances on the TSCA list.


Conflict Mineral Sources (US Dodd-Frank Act) and Cobalt (RMI) statement

The Stat-X group is not a publicly traded company in the United States and therefore not required to comply with US Dodd-Frank Act's conflict minerals provisions. However, many of our customers may be subject to this law.

The Stat-X Group has no reason to believe that any of our products were intentionally manufactured or used with "conflict minerals" as defined by the US Dodd-Frank Act or with neither "Cobalt" nor "Mica" as defined by the Responsible Minerals Initiative (RMI®).
